****NEWLY ADDED this year is the 1-Mile Memorial Walk – Walk in memory of a loved one or in honor of a firefighter****

TIME: 8K begins at 8:00 a.m; NEW **Memorial walk 8:05 a.m. and fun run approx. 9:15 a.m.

RACE LOCATION: Begins and ends at Sherrard City Park, 3rd St. & 5th Ave. Splits given at 1, 2, 3, & 4 mile marks.

COURSE: Relatively flat – starts and finishes at Sherrard City Park

PACKET PICKUP – Race day at Sherrard City Park, corner of 3rd St. & 5th Ave.

AWARDS: 8 K Awards – Overall male and female winners, and 3 in age groups: 19-under, 20-29, 30-39, 40-49, 50-59, 60-69, 70 and over.

1 Mile Kids' Fun Run will receive awards, with awards to finishers in each age group: Boys and girls - 6/under, 7/8, 9/10, 11/12

REFRESHMENTS: Food and drink for participants after the race, while they last

ENTRY FEES: 8K pre-registered by Wed. June 20th - \$22 (includes shirt), Late registration after

June 20th and race day - \$27 (shirts not guaranteed) *

1-Mile MEMORIAL walk - \$10 early and late registration (No shirt)*

1 Mile both pre-registered and race day - \$5 (includes hot dog meal, no shirt) or \$10 with shirt and hot dog meal

8K and 1-Mile MEMORIAL walk participants will receive \$2.00 off a Chicken or Fish Meal at our Annual Fish Fry being held that same day.
